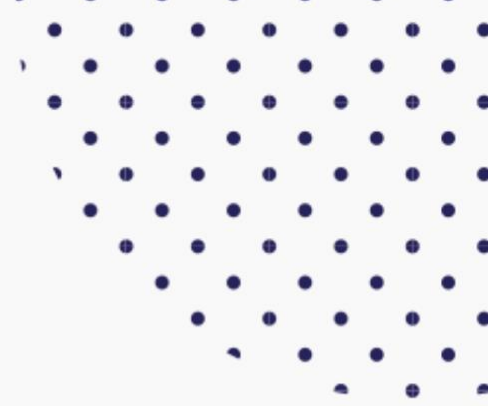

- POD and all pages of BOL(s) & paperwork required, must be submitted within 24 hours of delivery date, to invoice and issue payment in its entirety.
- Detention charges must be reported at time of incident along with BOL documenting times submitted within 24 hours of load emptying.
- All Refrigerated freight must be set at the right temperature, driver/carrier must check the temperature written on the BOL and compare it to the rate confirmation if the temperature is not matching on both documents driver/carrier must call Bowl M to get it resolved.

### Detention/ Layover Policy

- Must notify Bowl M that detention/layover is beginning. Failure to do so will lead to an automatic forfeit of detention.

- Detention pays ( 2 hours are free, upcoming 50\$ per hour )  
- Layover ( 250\$ per day )
